Each couple will then perform to a combination of drum beats including but not limited to Bora Bora, Mo'orea, Paea, Pahae and Vahine Tahiti, which will be provided by the specially selected House Drummers.

**PERFORMANCE DATE** The couples tamure will take place in the morning on Sunday, March 22, 2020.

**CHECK IN** Contestants must check in between 8:00 am - 9:00 am on their day of performance. Family and friends of competitors must purchase their own tickets.

**CATEGORIES** All couples will compete in one category, unless there are eight (8) or more couples, in which case an age division will be created.

**RULES AND REGULATIONS – COUPLES TAMURE**

- 1. ENTRY FORM** To become a competing couple, they must first fill out an entry form and return it with the entry fee by the required deadline.
  
- 2. COSTUMES** Couples will be dressed in matching costumes (i.e., both in Tahitian more 'ote'a skirts or both in pareo. Costume accessories (hei up'o, shells, leis, etc.) are optional. No handheld props or adornments. **NO PLASTIC OR SILK FLOWERS.**
  
- 3. ENTRY FEES** An entry fee will accompany the application form.
